PRODUCT RECALLS



PRODUCT/FIRM: Click High Chairs by Stokke

DESCRIPTION: This recall involves Stokke Click high chairs in white. The recalled high chair has a white molded plastic seat and foot rest with

wooden legs. Only Click high chairs that are white in color, have item number 552104 and within the following serial number range 135AA0057070 – 135AA0057908 are included in this recall. The item and serial number are printed on a label located under the seat of the high chair. The recalled high chairs were manufactured between December 16-18, 2020, and have Stokke Click High Chair on the label.

REMEDY: Consumers should immediately stop using the recalled white high chairs and contact Stokke for a free replacement. Consumers will receive the free replacement Click high chair in white after visiting Stokke's website to confirm their

product is included in the recall and registering the product online.

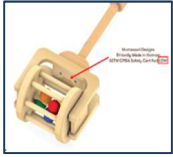


PRODUCT/FIRM: FAO Schwarz Branded Toy Wood Play Smart Robot Buddy(s) and Wood Sensory Boards by MerchSource

DESCRIPTION: This recall involves the FAO Schwarz Branded Toy Wood Play Smart Robot Buddy and the Toy Wood Sensory Board. The Robot Buddy is a sensory activity box with a robot factory inspired design featuring spinners, knobs and gear and bead manipulation activities. "Robot Factory" is written on the side of the activity box.

REMEDY: Consumers should immediately take the recalled toys away from children, stop using them, and contact MerchSource to receive a pre-paid label to return the recalled toys and instructions on how to receive a full refund.

PRODUCT/FIRM: Wooden Push Toys by Monti Kids

DESCRIPTION: This recall involves Push Toys, which are included with the Level 7 of the Monti Kids Program

subscription box. The Push Toy consists of a wooden handle attached to a rolling cylinder, which contains wooden balls. The lot numbers 0D41 and 1A41, “Montessori designs, Ethically Made in Vietnam, and ASTM CPSIA Safety Certified,” are printed on the underside of the handle, facing the rolling cylinder.

REMEDY: Consumers should immediately take the recalled toy away from children, dispose of the toy by throwing it into the trash, and contact Monti Kids to receive a \$40 refund. The firm is contacting all known purchasers directly.

PRODUCT/FIRM: Children’s Pajamas by The Red League

DESCRIPTION: This recall involves three styles of children’s sleepwear garments: one-piece, long-sleeve top and footed pajamas; two-piece, long-sleeve top and pant traditional pajama

sets; and two-piece, long-sleeve top and pant pajama sets.

REMEDY: Consumers should immediately take the recalled pajamas away from children and contact The Red League to receive a pre-paid mailer and instructions on how to return the garment(s) for a full refund. The firm is also contacting consumers who purchased the pajamas directly from The Red League to provide them a prepaid mailer to return the garment for a full refund.

PRODUCT/FIRM: Infant French Terry Jumpsuits, Rompers, Snap Suits, Baby Dresses and Bibs by Winter Water Factory

DESCRIPTION: This recall involves all infant French terry jumpsuits,

rompers, snap suits, baby dresses and bibs from the Fall 2020, Spring 2021, Fall 2021, and Spring 2022 seasons. The garments were sold in infant sizes 0M – 3T in various prints in the following styles: French terry jumpsuit, long-sleeve romper, summer romper, tank top romper, bubble romper, footed romper, long-sleeve snap suit, short-sleeve snap suit, Azalea baby dress, Oslo baby Dress, Juniper baby dress, Geneva baby dress, Merano baby dress, Kerchief bib, and French terry bib.

REMEDY: Consumers should immediately stop using the recalled jumpsuits, rompers, snap suits, baby dresses, and bibs and contact Winter Water Factory for instructions on how to receive a full refund or a refund in the form of a store credit. Consumers should destroy the recalled garments by cutting them in half with scissors and then upload a photo of the destroyed garment(s) to the company’s website. Upon receipt of the photo, consumers will be issued their choice of a full refund of the purchase price or a store credit with an additional 20% of the purchase price, whichever is higher.

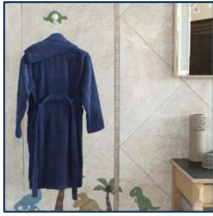
PRODUCT/FIRM: Children’s Robes; Imported by NewCosplay

DESCRIPTION: This recall involves NewCosplay children’s robes. The long-sleeved robes are made of 100% micro polyester and were sold in sizes 3T through 12. The robes were sold in 22

different patterns. The robes have a sewn-in side seam belt, two functional front pockets and a hood that is character theme with a mane, ears and horn. The sewn-in neck label displays the fiber content, washing instructions and “Made in China.” The sewn-in side seam label displays the garment’s size.

REMEDY: Consumers should immediately take the recalled robes away from children, stop using them, destroy them, and contact NewCosplay for a full refund. Consumers who purchased the robes from Amazon.com will be contacted by Amazon and NewCosplay directly.

PRODUCT/FIRM: Children's Robes by Linum Home Textiles

DESCRIPTION: This recall involves children's 100 percent cotton terry robes. The long-sleeved, hooded robes have two front pockets and a sewn-in, side-

seam matching belt. The robes were sold in sizes small, medium and large and in the following colors: white, navy, pink, gray and purple. "Made in Turkey," "100% Combed Turkish Cotton," the size and the washing instructions are printed on a sewn-in, side-seam label.

REMEDY: Consumers should immediately take the recalled robes away from children and contact Linum Home Textiles to receive a pre-paid mailer and instructions on how to return the robe(s) for a full refund. The firm is also contacting consumers who purchased the robes directly from Linum Home Textiles.

PRODUCT/FIRM: AmazonBasics School Classroom Stack Chairs by Amazon

DESCRIPTION: This recall involves AmazonBasics School Classroom

Stack Chairs. The chairs are made of durable plastic and have chrome-plated metal legs. They are stackable and were sold as a set of six chairs in pink, lime green, yellow, blue, purple, and/or red colors. They measure 17 inches long x 15 inches wide x 26 inches high. The chairs are recommended for ages three to six years old and for a weight of up to 190 pounds.

REMEDY: Consumers should immediately stop using the recalled chairs and contact Amazon for instructions on how to dispose of the chairs for a full refund. Amazon is contacting all known purchasers directly.

PRODUCT/FIRM: Woven Bunny Baskets by Bed Bath & Beyond

DESCRIPTION: The recalled baskets are white woven baskets with bunny faces that have either pink or blue cheeks and black

plastic eyes. The recalled baskets were sold with a tag that reads "HAPPY EASTER" and a hangtag that reads "! WARNING: THIS IS NOT A TOY, FOR DECORATIVE PURPOSES ONLY."

REMEDY: Consumers should immediately take the recalled baskets away from children and return them to any Bed Bath & Beyond location for a full refund.

PRODUCT/FIRM: Children's Cat & Jack Unicorn Cozy Pajama Sets by Target

DESCRIPTION: This recall involves a children's two-piece, long-sleeved top and pant pajama sets. The

pajama set is the brand "Cat & Jack" in the "Unicorn Cozy" pattern. The pajama top is black with ivory unicorns and ivory stars with the words "Dream Away" printed in metallic gold lettering. The pajama bottoms are ivory with black unicorns and black stars. The pajama set is 100% polyester and was sold in children's sizes XS, S, M, L, and XL. The product item number is printed on the inside sewn-in side seam label on both the pajama top and pant.

REMEDY: Consumers should immediately take the recalled pajama sets away from children and return the pajama sets to any Target store location for a full refund. Consumers who purchased the pajama sets on Target.com can contact Target to receive a prepaid return label to return the pajama set for a full refund. The firm is contacting known purchasers directly regarding the recall.

PRODUCT/FIRM: Aflac Plush Promotional Ducks by Communicorp

DESCRIPTION: This recall involves plush ducks that were distributed by Aflac to consumers as a promotional item. The six-inch

plush Aflac promotional ducks include Accident Duck, Business Duck (only with no model number printed on the sewn in tag are included in this recall), Fishing Duck, Police Duck, PGA Duck, One Day Pay Duck, Heisman Duck, and Lifeguard Duck.

REMEDY: Consumers should immediately stop using and dispose of the recalled plush promotional ducks. Communicorp is contacting Aflac employees and licensed agents who purchased these plush promotional ducks directly.

PRODUCT/FIRM: Children's Sleepwear by Copper Pearl

DESCRIPTION: This recall involves Copper Pearl children's pajamas made of 69% polyester, 28% rayon

and 3% spandex. The two-piece, long-sleeved pajamas were sold in two prints: fawn and polar. The tight-fitting sleepwear was sold in children's sizes 12M, 18M, 2T, 3T, 4T, and 5T. "Made by Copper Pearl," size and RN 151055 are printed at the neck.

REMEDY: Consumers should immediately take the recalled sleepwear away from children and contact Copper Pearl for a full refund. Consumers who purchased the sleepwear directly from Copper Pearl will be contacted via email and provided prepaid mailers to return the garment(s) for a full refund. Consumers who purchased the sleepwear at retail locations will be asked to destroy the garments by cutting them in half and sending the firm a photo of the destroyed product, including the neck label. Upon receipt of the photos, consumers will be issued a full refund and a 20% off discount code towards another purchase.

PRODUCT/FIRM: Wonder & Wise Activity Tables by Asweets

DESCRIPTION: This recall involves Wonder & Wise-branded activity tables designed for standing babies and toddlers. The square wooden tables measure

about 21.5 x 21.5 x 23.5 inches. The toys on the table are made of wood and metal. The tables are black, white, and natural wood colors. The top of the table includes removable stacking toy animals, a xylophone, bead maze, sorting and stacking puzzles, and a train track. The center maze pulls up to access a fabric storage pouch that is attached to the table.

REMEDY: Consumers should immediately stop using the recalled activity tables, store them away in a place children cannot access until repaired, and contact Asweets for a free repair kit, including shipping. The repair kit includes a replacement tabletop that includes a block sorting activity in place of the xylophone.

PRODUCT/FIRM: Children's Pajamas by Free Birdees

DESCRIPTION: This recall involves Free Birdees' children's 95% viscose and 5% spandex pajamas. The two-piece, short or long-sleeved

pajamas, were sold in sizes 6-12 months, 12-18 months, 18-24 months, 2T, 3T, 4T, 5, 6, 7, 8, 10, and 12, and in three prints: green tractor, green stripe, and tropical fish. Free Birdees, the size, and RN 157155 are printed at the neck.

REMEDY: Consumers should immediately take the recalled pajamas away from children and contact Free Birdees for a full refund. Consumers who purchased the sleepwear garments will be asked to destroy the garments by cutting them in half and send the recalling firm a photo of the destroyed garment and of the garment's neck label. Upon receipt of the photos, consumers will be issued their choice of either a full refund or a store gift card. Free Birdees is contacting all known purchasers directly.

PRODUCT/FIRM: Hover-1 Superfly Hoverboards by DGL Group

DESCRIPTION: This recall involves model year 2020 Hover-1 Superfly Hoverboards model H1-SPFY. They were sold in black only with blue LED lights on the hoverboard deck near the foot pads. Hover-1 is written on the front of the hoverboard. Recalled hoverboards have a serial number on the bottom of the hoverboard beginning with SPFY-BLK-GO-2008, SPFY-BLK-GO-2009 or SPFY-BLK-GO-2010. A warning label can be found on the bottom of the hoverboard next to the serial number. The warning label, at the bottom right, states "H1-SPFY."

REMEDY: Consumers should immediately stop using the recalled hoverboards and contact DGL Group for instructions on how to ship affected units to an authorized repair shop free of charge.

PRODUCT/FIRM: Baby bottles by BIBS Denmark ApS

DESCRIPTION: This recall involves the BIBS Baby Glass Bottle Complete Set which was sold as a 110 ml or 225 ml bottle set with a rubber bumper at the bottom and the BIBS Bottle Kit which is only the accessories including the rubber bumper and no glass bottle. The bottles are clear glass with a gray cap and bumper. BIBS and a measuring guide are written on the bottles.

REMEDY: Consumers should immediately stop using the recalled BIBS baby bottles with the bumper and either return the product to BIBS for a full refund or remove and throw out the bumper and use the product without the bumper. If you purchased the bottle online through the BIBS website and wish to return it, contact BIBS Denmark ApS for free shipping.

PRODUCT/FIRM: Wood Baby Activity Push Walkers by Asweets

DESCRIPTION: This recall involves four-wheeled Wonder & Wise baby activity walkers. The wooden push walkers have a panel of interactive toys

and activities for babies. They are white with black and wood-colored accents, with a front panel with a shape sorting puzzle, bead activities and other wooden toys and a storage compartment. A roller containing five wooden balls is attached between the two front wheels. Only units with no batch number label, or units labeled with Batch No. 0521SCP01155 on the undercarriage of the walker are recalled.

REMEDY: Consumers should immediately take the recalled walkers away from children, stop using them until repaired, and contact Asweets for instructions on getting free replacement rear wheels.

PRODUCT/FIRM: Children's Robes by Joey Clothing

DESCRIPTION: This recall involves Leveret branded children's robes. The robes are made of cotton and nylon, have an attached hood, cuffed wrists, two functional front pockets and a detachable belt. The robes were sold in children's sizes 12-18 months through size 14 and in the following colors: black, dark blue, green, gray, navy, pink, purple, and white. The sewn-in neck label displays the brand Leveret, the robe's size, material content, washing instructions, and "Made in China."

REMEDY: Consumers should immediately take the recalled robes away from children, stop using them and contact Joey Clothing for a full refund. Consumers who purchased the robes from Amazon.com will be contacted through Amazon's messaging platform. Consumers who purchased the robes directly from Joey Clothing, Nordstrom Rack, and Zulily will be contacted via email. Consumers must cut the robes in half and send photo proof of the destroyed robes and sewn-in label to receive a \$30 refund via email at productrecall@leveret.com. Joey Clothing will refund \$35 to consumers who show a receipt of the full purchase price. Consumers without a receipt will be refunded \$30.

DESCRIPTION: This recall involves Times Tienda Children's Desks and Chairs. The desks were sold in blue,

pink, and green and the children's desk with chair was sold in green. The product number is printed on labels on the underside of the desk and chair. The desks and chairs have metal folding legs.

REMEDY: Consumers should immediately stop using the recalled children's desks and chairs and return them to a Times Tienda store for a full refund.

DESCRIPTION: This recall involves Primark wooden xylophone toys. They have pastel-colored metal xylophone bars

and wooden percussion stick. It is intended for children 10 months and older.

REMEDY: Consumers should immediately stop using the recalled xylophone and return it to a Primark store for a full refund.

DESCRIPTION: This recall involves Jungle Jumperoo children's toys. The toys have a blue metal base, a black rubber tube, and two blue, green, red, and yellow vertical metal poles to hold onto when jumping. They measure 77 inches tall by 55 inches wide by 55 deep. Only the large Jungle Jumperoo toys are included in this recall. The Jungle Jumperoo logo and the phrase "a wild way to bounce" are printed on the tube.

REMEDY: Consumers should immediately stop using the recalled toys and contact Jungle Jumperoo

for information on how to properly dispose of the yellow poles and to receive free replacement poles, including shipping. Jungle Jumperoo is contacting all known purchasers directly.

PRODUCT/FIRM: Activity Loops Toys for Infants by The Manhattan Toy Company

DESCRIPTION: This recall involves the Manhattan Toy Company's Activity Loops with model number 215210 and lot codes EAN or FCN. The recall applies to these two lot codes only. The model number and lot code can be found printed on the bottom of the dome shaped base. The loops are green, orange, blue and red and have moving rings and sliding soccer ball shapes. The toy has a suction cup bottom that adheres to non-porous flat surfaces.

REMEDY: Consumers should immediately stop using the Activity Loops toys, take the toys away from children, and return them for a full refund either to the place of purchase or directly to Manhattan Toy. Manhattan Toy will supply a prepaid shipping label for returns directly to the company.

DESCRIPTION: This recall involves Baby Boy Dino Rompers and Baby Boy Camo Rompers 2-Pack. The Dino Romper is a blue short-sleeve romper made of 100 percent cotton jersey featuring a dinosaur on the left chest and was sold in sizes 0-3M, 3-6M, 6-9M, 9-12M, 12-18M, and 18-24M. The Camo Romper Two Pack was sold in sizes 0-3M, 3-6M, 6-9M, 9-12M, 12-18M, and 18-24M and contained one gray long-sleeve romper made of 100 percent cotton jersey in a camouflage print and one gray short-sleeve romper with black shoulders and sleeves. The Baby Boy Dino style number 3031536 can be found on a sewn-in, side-seam label inside the garment. The Baby Boy Camo Romper 2-Pack

style number 3026902 can be found on a sewn-in, side-seam label inside the garment.

REMEDY: Consumers should immediately take the recalled rompers away from children and return the rompers to any The Children's Place store for a full refund. The company will send an email notice to all customers who bought the product on the firm's website with instructions on how to receive a full refund for the recalled products.

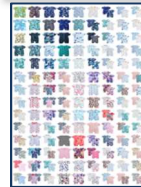


PRODUCT/FIRM: Children's Sleepwear Imported by Loulou Lollipop
DESCRIPTION: This recall involves Loulou Lollipop children's pajamas made of 66% Tencel lyocell, 28% organic cotton, and 6% spandex. The one-piece, long-sleeved pajamas were

sold in 19 prints: Avocado, Bluebell, Butterfly, Canyon Rainbow, Flower Vine, Grey Mudcloth, Morning Dew, Moon, Nomad, Peace Dove, Planets, Painterly Seahorses, Rainbow Dye, Shell Floral, Sepia Rose, Sepia Rose Floral, Seashells, Sun, and Umbra. The tight-fitting sleepwear was sold in two children's sizes 12-18M and 18-24M. "Loulou Lollipop," size and purchase number are printed at the neck. The purchase numbers included in this recall are SS22-GR-APP-001 and AW2021-APP001.

REMEDY: Consumers should immediately take the recalled sleepwear away from children and contact Loulou Lollipop for a full refund. Consumers who purchased the sleepwear will be asked to destroy the garments by cutting them in half and sending the firm a photo of the destroyed product, including the neck label.
