## PRODUCT RECALLS

**PRODUCT/FIRM:** Glion SmartScooter Model 100 by Probity Cell Black and White Unfolded

**DESCRIPTION:** The frame of the scooter can break




where the unit folds, posing a fall hazard. **REMEDY:** Consumers should immediately stop using the recalled electric scooters and contact Probity

Cell for a free repair or a store credit toward the purchase of another product. BRAND/MODEL: FULLBEAUTY Brands Children's Nightgowns **DESCRIPTION:** This recall involves girl's Dreams & Co.® by FULLBEAUTY Brands knit cotton jersey "daughter Henley" styled nightgown. The nightgowns have picot edge trim and a button placket on the center front of the chest. The nightgowns were sold in children's sizes 6/6X, 7/8 and 10/12. The style number is printed on the side seam label of the nightgown. REMEDY: Consumers should immediately take the

recalled nightgowns away from children and contact the firm for instructions on receiving a full refund or a company gift card for 125% of the purchase price. The firm is contacting consumers that purchased the recalled nightgowns. Bubblina Spa & Shower infant bath tubs with fabric slings **DESCRIPTION:** This recall involves Lil' Luxuries Whirlpool, Bubbling Spa & Shower with fabric slings. The infant

bath tub is a batteryoperated whirlpool bath with motorized jets intended for use with children from birth to two years. The product contains a fabric sling on a plastic frame onto which the infant is placed for bathing. The fabric sling on the recalled bath tubs does not have a white plastic attachment clip to hold the headrest area of the fabric sling to the plastic frame. Recalled bath tubs have item numbers 18840, 18850, 18863, and 18873 and were sold between October 2012 and October 2013. These contain date codes starting with 1210, 1211, 1212, 1301, 1302, 1303, 1304, 1305, 1306, 1307, and 1308, which stand for the two-digit year followed by the two-digit month, on the fabric sling. REMEDY: Consumers should immediately stop using the fabric sling in the recalled product and contact Summer Infant for a replacement fabric sling with a white plastic attachment clip. **PRODUCT/FIRM:** Mamas ጲ Papas Armadillo Flip Strollers **DESCRIPTION:** This recall involves Mamas & Papas' Armadillo Flip and Armadillo Flip XT strollers. All models are folding, single-occupant infant strollers. The strollers come in various colors including black.

teal, and navy and weigh about 22 pounds. Recalled items can be identified by their lot number, which is the month and year of manufacture. Lot number ranges for recalled Armadillo Flip strollers are 00814 through 00416 (August 2014 through April 2016). Lot number ranges for the Flip XT are 01214 through 00416 (December 2014 through April 2016). The lot number is printed on the sewn-in label on the stroller. REMEDY: Consumers should immediately stop using the strollers and contact Mamas & Papas for a free repair at 800-309-6312 anytime, or visit www.mamasandpapas.com/us and click on "Recall Notice" for more information.

PRODUCT/FIRM: Roylco Educational Light Cubes DESCRIPTION: This recall involves the Roylco



**Educational Light Cubes** with model number R59601. The model number is located on the user guide included with the light cube. The educational light cube is a white cube measuring 16 inches high by 16 inches wide by 16 inches deep. The cubes

have a light source and a battery located in the base. The cube is primarily used for creative learning involving light in the early childhood classroom.

**REMEDY:** Consumers should immediately stop using the recalled light cubes and contact Roylco for instructions on returning the light cubes for a free replacement of the light source, which contains the battery. **PRODUCT/FIRM:** Chimparoo Baby Carriers by L'echarpe Portebonheur **DESCRIPTION**: This recall involves Chimparoo brand Trek baby carriers that allow the user to carry a baby tummy to tummy, on the hip, or on the back. The 100% twill fabric carriers were sold in 18 solid, striped, and pattern color combinations. The

carriers attach to the wearer's body with adjustable straps made of polypropylene webbing and plastic buckles. "Chimparoo" is printed on the upper right hand corner of the carrier. "Trek" is embroidered on the belt. **REMEDY:** Consumers should immediately stop using

the recalled baby carriers and contact Chimparoo for a free replacement buckle for the baby carrier's side buckle. ## PRODUCT/FIRM: Fiddle Diddles Car Seat Strap

**DESCRIPTION:** Systems This recall involves Fiddle Diddles LullaBelav adjustable car seat strap system with model number LB1001. The strap system includes two fabric straps. carabiner hardware, a mesh car seat cover and a tote bag. The carabiners are used to hang a



car seat from a shopping cart. The model number is printed on the gray straps. "Fiddle Diddles" is printed on a fabric label attached to the mesh car seat cover, tote bag and fabric straps. REMEDY: Consumers should immediately stop using the LullaBelay strap system and contact Fiddle Diddles for a free repair kit with three new carabiners. The firm is contacting all known purchasers directly. PRODUCT/FIRM: Peg Perego Children's Ride-On Vehicles **DESCRIPTION:** This



recall involves Peg

Perego's 850 Polaris Sportsman ride-on. 24-volt battery operated toy vehicles intended for children ages 5 to 7 years. The ATV-style vehicles for two people are silver, red. and

black. They have four wheels, a flip-up backrest for the back passenger, and a front and rear luggage rack. Vehicles with date codes 651016, 651017, 651020, 651021, 651022, 651023, 651024, 651027, 651028, 651029, 651030, 660304, 660305, 661123, 661124, 661125 and 661130 are included in this recall. The date code can be found underneath the vehicle seat. Sportsman Twin and 850 EFI appear on the side of the ride-on vehicle and Polaris appears on the side of the Consumers **REMEDY:** vehicle's seat. should immediately stop children from using the recalled toy vehicles and contact Peg Perego to receive a free replacement circuit board with instructions (including shipping). Consumers can also access the installation instructions on the firm's website. Peg Perego is contacting known customers directly. **PRODUCT/FIRM:** Skidders Footwear Children's Shoes **DESCRIPTION:**. This recall involves Skidders Footwear



children's canvas tennis shoes sold in three sizes: 12M, 18M and 24M. The shoes have rubber white bottoms and come in three different colors: navy blue fabric

with orange rivets and laces, gray fabric with green rivets and laces, and denim colored fabric with pink rivets and laces. **REMEDY:** Consumers should immediately take the recalled shoes away from children and contact Skidders Footwear to receive a full refund. **PRODUCT/FIRM:** Baby Bath Seats/Chairs Made bv Lexibook DESCRIPTION: This recall includes all Lexibook Baby Bath Seats and Chairs. The plastic baby bath seats/chairs are intended for children six months and up. They have a plastic base with suction cups on the bottom, a

back/arm support, and a toy tray. "Lexibook" is stamped on the back/arm support. "Made in China" and "2014 Lexibook Limited IT028/IT029 SN: 1407/VA09" are stamped on the bottom of the base. They were sold in a variety of colors. **REMEDY:** Consumers should immediately stop using the recalled baby bath seats and contact the online retailer where it was purchased for return instructions and to receive a full refund, or a refund in the form of a store credit or gift card, depending on the online retailer. All known purchasers will be contacted directly about the recall.

**PRODUCT/FIRM:** Playworld Stainless Steel Playground Slides **DESCRIPTION:** The recalled slides are made of stainless steel and have both single and double bedways. There are welds on both sides of the slide attaching the



bedway to the sidewalls, and the welds run continuously from the top to the bottom. There are no identifying

marks on the slides. **REMEDY:** Consumers should immediately stop using the recalled slides and contact Playworld for a free replacement slide and free installation. A temporary barrier will be shipped to consumers prior to shipment of a replacement slide to prevent children from using the slide. Playworld is contacting consumers who purchased the slides directly. PRODUCT/FIRM: Chicken



**DESCRIPTION:**. This recall involves the Bump 'N Go Walking Egg Laying Chicken with light, sound, and music. The batterypowered plastic toy is a yellow chicken with an orange head and orange wings. The chicken toy includes three white plastic

eggs that are placed into the back of the chicken and then released from the bottom. The chicken measures 7 inches wide by 6 inches tall by 7 inches deep. The eggs measure one inch wide by one inch tall by one inch deep. "QQ Chicken" is printed on the wing. A small yellow chicken sits on the chicken's back. REMEDY: Consumers should immediately take the chicken toy and eggs away from children and contact Bingo Deals for a full refund. Bingo Deals is contacting consumers who bought the toy directly. PRODUCT/FIRM: Aria Child Strollers **DESCRIPTION:** This recall involves the gb Qbit lightweight stroller for children up to 50 pounds. The recalled strollers have 4 sets of two wheels, a five-point harnessed restraint system, a full-sized reclining seat, а storage basket, a removable cup holder, and a travel storage bag. The strollers can also be used as a travel system with

infant carriers. The strollers are mostly black with an accent color. The "gb" red box logo is printed on the harness and on both sides of the stroller legs and "Qbit" is printed in white on the stroller legs. The model number and date of manufacture are printed on a sticker on the rear leg of the stroller, directly above the wheels, next to the storage basket. **REMEDY:** Consumers should

immediately stop using the recalled strollers and contact Aria Child for a free replacement stroller. Consumers may contact Aria Child toll-free at 888-591-5540 from 7:00 AM to 4:00 PM CT Monday through Friday, or visit www.ariachild.com and click on "Qbit Lightweight Stroller Voluntary Recall Information" for more information.



**PRODUCT/FIRM:** Tea Collection Children's Denim Jackets **DESCRIPTION:** This recall involves Tea Collection Inc. children's knit blue denim jackets with metal buttons and snaps. A tag sewn inside the neck reads "Tea." Style number 6F22400-405 is printed on a

hangtag attached to the garment. The jackets were sold in sizes XS to XL (sizes 2 through 12). **REMEDY:** Consumers should immediately take the recalled jackets away from children and contact Tea Collection Inc. to receive a full refund. They have a low foot-gripping deck, multicolored handgrips, and an adjustable metal T-bar handle. The scooters are made of metal and plastic and come in a variety of colors. The tracking label sticker can be found on the back of the scooter, with batch PO number of G20140423. Recalled model numbers are: GT5048R, GT5110R, GT5121R, GT5124R, GT5125R, GT5122R, GT5117R, and GT5123R. Model numbers can be found on the bottom of the scooter base, on the receipt and on the packaging **REMEDY:** Consumers should immediately stop using recalled scooters and contact GLOPO for instructions on receiving a free repair kit.
