PRODUCT/FIRM: Thousandshores Recalled Theefun Kids Gardening Tools Sets Due to Violation of the Federal

Phthalates Ban; Sold Exclusively on Amazon **DESCRIPTION:** This recall involves toy Theefun Kids Gardening Tools sets with the model number HJL-001. The kids' tools were sold in a pack of five different garden tools with wooden handles, and brown handle string on each handle. The tools measure about 27 inches in length.REMEDY: Consumers should immediately take these recalled toy gardening tools sets away from young children, and contact

Thousandshores to receive a full refund. Consumers should cut off the brown handle strings from the gardening tools and dispose of them in accordance with local and state recycling laws. Exclusively on Temu.com through Outad Good Life **DESCRIPTION:** This recall involves magnetic chess games with 20 magnet stones that are small, spherical, loose, and separable with a strong magnetic flux. The games are sold in a blue box with the words "Magnetic", "Magnetism", or "Magnetism Intelligence Strategy Game" on the front of the box. The game includes about 20 loose

magnets, a string, a plastic storage tray with sponge lining, and instructions for play.

REMEDY: Consumers should stop using the recalled magnetic chess games immediately, take them away from children, and contact Outad Good Life for instructions on how to receive a full refund. PRODUCT/FIRM: Sling Carriers Recalled Due to Infant Suffocation and Fall Hazards; Violation of the Federal Safety Regulation

for Sling Carriers; Sold on Walmart.com through Joybuy Marketplace Express

DESCRIPTION: This recall involves the Joybuy Marketplace Express sling carriers designed to be worn by an adult to carry an infant. The carriers include an adjustable shoulder strap, black plastic buckle, and black hook-and-loop waist and crotch restraint. The exterior is solid navy fabric, and the interior colors and patterns vary. The brand name is not listed on the products. Due to the absence of labeling, consumers should review their purchase history to determine if their sling carrier is one with the product name and seller identified in the table below affected by this recall.

DESCRIPTION: This recall involves padded crib bumpers sold in the following colors: gray with white clouds, teddy bear, light pink, and white. They were sold in a clear plastic bag. There are no markings or labeling on the crib bumpers.

REMEDY: Consumers should immediately stop using the recalled crib bumpers and contact AliExpress for a full refund. To receive a refund, consumers should destroy the crib bumpers by cutting the straps and the padding and send a photo as proof of destruction by directly replying to the email from AliExpress. REMEDY: Consumers should immediately take the recalled nightgowns away from children, stop using them, and contact Zegoo Home to receive a full refund. DESCRIPTION: This recall involves SIORO-branded 100% cotton, terry cloth children's robes. They are long-sleeved with a hood, two front pockets, and a matching belt. The robes were sold in the following additional colors: Rose Pink, Light Pink, Pure White, Falcon Gray and Green Mist, with Light Blue, Navy, Peacock Blue, Gray Blue and Plum colors in the original recall. Sizes sold include 4-5T, 6-7 Years, and 8-10 Years. On the front of the neck label is a flamingo, "100% Cotton", and "Made in China". On the back of the neck label are washing instructions.

REMEDY: Consumers should immediately take the recalled robes away from children, stop using them, and contact SIORO for a full refund. Consumers should destroy the garments by cutting them in half, and send a photo of the destroyed garment to amazonus@sioro.com. Upon receipt of the photo,

DESCRIPTION: This recall involves

SKIMS fleece children's pajama sets. The two-piece, button-up pajamas have long sleeves and wide-legged pants. They were sold in blue and black, multi-colored, green and black (cypress), and burgundy and black (wine) plaid patterns, and in sizes 2T, 3T, 4, 5, 6, 7, 8, and 10. "SKIMS", the size, and "Made in Philippines" are printed on the neck label. The side seam label lists the size, fiber content, washing instructions, "Made in Philippines", and "RN158973".

REMEDY: Consumers should immediately take the recalled pajamas away from children, stop using them, and contact SKIMS for a full refund. They were sold in various colors, including: pink top and purple body; purple top and pink body; blue top and green body; and green top and blue body.

REMEDY: Consumers should immediately take the recalled bottles away from children, stop using them, and contact Igloo to receive a replacement bottle or refund. Consumers should destroy the silicone spout by removing the silicone spout and cutting it into two separate pieces down the center. Consumers should then take a photo of the spout in two separate pieces, then discard the two pieces in the trash. About 940 of these bookcases were sold exclusively at Dania Furniture stores nationwide and online at https://daniafurniture.com/ from November 2017 through February 2024 for about \$370.

The recalled Hayden bookcase contains six storage cubbies, and is made of brown wood with three sliding white doors. It measures 35.5 inches in width, 16 inches in depth, and 73 inches in height. A label located on the

back of each unit contains the product name and SKU number LB2225/A.

The bookcases were distributed by Dania Furniture. They were manufactured in Italy.

Consumers should immediately stop using the recalled bookcase if it is not anchored to the wall and place it in an area that children cannot access. Contact Dania Furniture to set up a free in-home installation of a tipover restraint kit. If mounting/anchoring services cannot be completed for any reason, or if consumers would prefer a refund, Dania Furniture will provide a full refund of the purchase price of the recalled bookcase to consumers and arrange for the pickup and/or disposal of the recalled bookcase. Dania Furniture is also contacting all purchasers directly.

CPSC urges consumers to report any related incidents to the agency at www.SaferProducts.gov.

REMEDY: Consumers should immediately stop using the recalled bookcase if it is not anchored to the wall and place it in an area that children cannot access. Contact Dania Furniture to set up a free in-home installation of a tip-over restraint kit. If mounting/anchoring services cannot be completed for any reason, or if consumers would prefer a refund, Dania Furniture will provide a full refund of the purchase price of the recalled bookcase to consumers upon its return, and arrange for the pickup and/or disposal of the recalled bookcase. Dania Furniture is also contacting all purchasers directly.
