PRODUCT/FIRM: BCI Burke Recalls Playground Merry-Go-Rounds Due to Crush

DESCRIPTION: This recall involves the

Inclusive Orbit, a spinning play component, similar to a merry-go-round, for playgrounds. The product has three handrails and a seat, and it is designed for a capacity of six children. The platform surface is flush with the ground surrounding it. Recalled model numbers include 560-0042 or 560-0051. Owners of the equipment can contact BCI Burke to determine which unit they have. PRODUCT/FIRM: Melii Baby Silicone Spoons for



Babies Recalled Due to Choking Hazard; Imported by Melii Baby

DESCRIPTION: This recall involves Melii Baby Silicone Spoons for babies with animal

shapes at the handle. They were sold in packs of either three or four and as a five-piece silicone

feeding set. The feeding sets were sold in cat, dino, dog, shark and unicorn shapes. The spoons measure about

six inches long. The affected spoons have the following date codes: the three-pack 2024-01 and the four-pack have 2023-12 to 2024-05 printed on the back of the spoons. All spoons in all Baby 5-Piece Silicone Feeding Sets are affected by this recall.

REMEDY: Consumers should immediately stop using the recalled spoons, keep them away from children and contact Melii Baby Inc. to receive a free replacement set. Consumers should take photographs of the spoons, discard the spoons in household waste, and then email the photographs to care@meliibaby.com to receive the free replacement set.

DESCRIPTION: This recall involves multicolored magnetic building sticks sets with 130 pieces with 100 magnetic sticks and are plastic and metal. The sets are sold in a box with the "Elongdi" logo and the words "Magnetic Sticks" on the front and back of the box. The set includes 30 steel balls. The item number is E107. REMEDY: Consumers should stop using the recalled magnetic building stick sets immediately, take them away from children, and contact Elongdi to receive a pre-paid label to return the recalled magnetic building sticks for a full refund. Amazon is notifying all known purchasers directly.

PRODUCT/FIRMMr. Christmas Recalls Wireless Decorative Tree Light Controllers Due to Fire Hazard

DESCRIPTION: This recall involves a decorative tree light controller that operates

wirelessly to turn on holiday lights on a tree. The decorative controller contains two parts: a lever or a switch that can be pulled to turn the holiday lights on or off, and a separate white receiver that plugs into an outlet and into which the tree's holiday lights are plugged. The controller sold at Walmart and Cracker Barrel is shaped like a green, red and white peppermint candy with a candy cane on/off lever, and displays the words "Christmas Light Controller". The controller sold at Target is sold under the Wondershop™ brand and is shaped like a square on/off switch box with green, red and white balls, and displays the words "Tree Lighting Switch". The white wireless receptacle that is plugged into an outlet contains the words "Mr. Christmas" and one of these three model numbers printed on the white

receptacle: 39611, 39612 or 39630 ■

REMEDY: Consumers should immediately stop using this product and return it to their place of purchase to receive a full refund.

PRODUCT/FIRM: South Shore Cribs Recalled Due to Entrapment Hazard; Violation of Federal Regulation for Full Sized Cribs; Imported by South Shore

DESCRIPTION: This recall involves South Shore brand Balka & Olena cribs sold in white and natural wood colors. The cribs are made of wood and measure about 37 inches high, 54 inches long and 30 inches deep. The model number is printed on an adhesive label on one end of the crib.

REMEDY: Consumers should immediately stop using the recalled cribs and contact South Shore for information on how to disassemble the product. PRODUCT/FIRM: Todson Recalls Nerf Barrage Bicycle Helmets Due to Risk of Head Injury; Violation of Federal Regulations for Bicycle Helmets; Sold Exclusively at Walmart

DESCRIPTION: This recall involves Nerf Barrage Youth bike helmets. The helmets have a blue/orange exterior, black straps, an orange buckle, and are size medium (M). NERF is printed in white lettering on the sides of the helmet. Model 6011 is printed on a label on the inside of the helmet. The lot number (LOT#) and reference number (REF#) can be found on the same label on the inside of the helmet. Only helmets with LOT# BC01BJ01-200623 and REF# 5382-BL and LOT# BC01BJ01-111521 and REF# 4970-BL are included in this recall.

REMEDY:Consumers should stop using the recalled Nerf Barrage helmets immediately and contact Todson Inc. for a full refund. To receive a refund, consumers should destroy the helmet by cutting off the straps, then take a photo, and send the photo to the recalling firm by email at NerfHelmetRecall@Todson.com. PRODUCT/FIRM: Segway Recalls Segway Ninebot P100 KickScooters Due to Fall and Injury Hazards

DESCRIPTION: This recall involves Segway Ninebot KickScooters with model number P100S and a manufacture date in 2023. The affected units have serial numbers containing the date codes 2308 or greater xxxxx2308xxxxx. (e.g., xxxx2310xxxxx. xxxxx2311xxxxx). The serial number is located on the left side of the KickScooter. The 6th and 7th digits represent the year of manufacture, and the 8th and 9th digits represent the week of manufacture. The product is black and gray with red accents, and the Segway label is on the rear fender. The KickScooter is 46 inches long, 25 inches wide and 50 inches high, and weighs about 72.5 pounds. **REMEDY:** Consumers should immediately stop using the recalled KickScooters and contact Segway for a free repair. Segway will direct consumers to a local store for

the repair (where available) or provide a pre-paid shipping label to ship the product to a national service center for repair. Segway is contacting all known purchasers directly.

PRODUCT/FIRM: Stokke Recalls YOYO³ Strollers Due to Injury Hazard

DESCRIPTION: This recall involves YOYO3 strollers with serial numbers starting with "142AA" followed by numbers that fall below "0062239." Only

strollers with these numbers are affected. The compact four-wheel foldable strollers are designed for children aged approximately 0 to 48 months. The stroller frame is black or black and white, and the stroller seat and canopy are black, Bonpoint beige, stone, olive, taupe, toffee, ginger, Air France blue or aqua. The wheels have a white reflective center. The serial number is located on a tracking label under the stroller seat.

REMEDY: Consumers should immediately stop using the recalled strollers and go to https://recall.stokke.com/yoyo3 to register their product to receive a full refund in the form of a refund check.

PRODUCT/FIRM: Petidoux Recalls Children's Pajamas Due to Burn Hazard; Violation of Federal Flammability Regulations for Children's Sleepwear

DESCRIPTION: This recall involves Petidoux's short sleeve/shorts children's pajama set, advertised as "Celebration Girl's Summer Pajamas". The 100% cotton pajama top and bottom are white with an allover firework print in the colors red, white and blue. The top has blue trim on the sleeves and collar, and a small, blue bow on the center of the collar. The shorts have blue trim on the bottom. The pajama sets were sold in sizes 1, 2, 3, 4, 5, 6, 7, 8, 10 and 12. The neck is printed with a label in both English and French. The English is printed on the left and states "Petidoux", "WEAR SNUG-FITTING NOT FLAME RESISTANT", "100% PIMA COTTON", "Designed in New York", "Made in Peru", "RN 143635", the size, washing instructions and lot number #713705.

REMEDY: Consumers should immediately take the recalled pajamas away from children, stop using them,

and contact Petidoux for a full refund. Consumers will be asked to destroy the garments by cutting the top and bottom in half and disposing of them in accordance with local and state recycling procedures. Consumers must send a photo of the destroyed garment to customerservice@petidoux.com. Upon receipt of the photo, consumers will have the option of receiving a full refund or a store credit worth 1.25 times the purchase price.

PRODUCT/FIRM Baofali Crib Bumpers Recalled Due to Suffocation Hazard; Violation of Federal Ban on Crib Bumpers; Sold Exclusively on Temu.com by Unique Person Home Goods

DESCRIPTION: This recall involves Baofali 4-in-1 Microfiber Crib Safety Bumpers with model numbers JJ25B-A1, JJ25B-A2 and JJ25B-A3. They are sold in white, gray and pink colors and have a rectangular shape with fabric ties attached. They are approximately 52 inches long by 10 inches tall.

REMEDY: Consumers should immediately stop using and remove the recalled crib bumpers from the crib. To receive a full refund, take a photo of the crib bumper cut in half and email the photo to <u>2540535966@qq.com</u> or message to <u>Baofali Trading</u> on Temu.com. Dispose of the destroyed crib bumper in accordance with local and state laws. PRODUCT/FIRM: Guava Family Recalls Roam Strollers Due to Fall and Injury Hazards

DESCRIPTION: This recall involves Guava Roam First Generation threewheel foldable strollers manufactured

between July 2020 and December 2021. The strollers are "first generation" if they have a manufacture date between July 2020 and December 2021. They have a black frame with the "Guava" logo in gray on the frame. The seat, canopy and storage compartment are black. The strollers measure about 39 inches long by 25 inches wide by 43 inches high, and weigh about 28.5 pounds. The black label on the cross bar below the seat has "Guava Family Inc." and includes the model name Roam, model number, and date of manufacture. Only First Generation strollers with a manufacture date between July 2020 and December 2021 are included in the recall.

REMEDY: Consumers should immediately stop using the recalled strollers and contact Guava Family for instructions on how to register for a free repair kit and new installation instructions.

DESCRIPTION: This recall involves Kyte Baby Slumber Suits, which are one-piece sleep garments for babies. "Kyte Baby", the size, "Made in China" and care instructions are printed on the inside neck label. The recalled Slumber Suits were sold in sizes Medium (M), Large (L) and Extra Large (XL), and the colors Midnight, Taro, Slate, Sage, Blush, Cloud, Alpine Village, Crepe, Racoon, Jurassic, Eucalyptus, Blue Heron, Cloud Poppies, Haze, Midnight Poppies and Coastline.

PRODUCT/FIRM: Dreamgro Recalls Lullaby Travel Soothers Due to Choking Hazard DESCRIPTION: This recall involves Dreamgro lullaby travel soothers for infants. They are shaped as a mermaid, have a soft gold star attached to the mermaid's head, and were sold in light blue and pink colors. The soothers play music and have a

detachable hook that attaches to car seats and strollers. The Dreamgro name and model numbers are located on the soother's tag.

REMEDY: Consumers should immediately stop using the recalled soothers and take them away from children. Return the soother to the store where purchased for a full refund.

*DESCRIPTION: his recall involves Vevor Baby Gates. They are marked "Vevor, Tough Tools Half Price" on the handle and come with five screws and four wall cups. The pressure-mounted gates open both inward and outward. They are made of iron (powder-coated) and plastic material and come in white and black colors. They measure about 30 inches high with an adjustable width from about 29.5 inches to 39 inches.

PRODUCT/FIRM: Fisher-Price Recalls More than 2 Million Snuga Infant Swings Due to Suffocation Hazard After 5 Deaths Reported

DESCRIPTION: Washington, D.C. --

The U.S. Consumer Product Safety Commission (CPSC) and Fisher-Price are announcing the recall of Fisher-Price Snuga Swings. The swing should never be used for sleep and bedding materials should never be added to it. If the product is used for sleep or bedding material is added, the headrest and body support insert on the seat pad can increase the risk of suffocation. Consumers should immediately remove both the headrest (by cutting the tether) and the body support insert from the seat pad before continuing to use the swing for awake-time activities.

Between 2012 and 2022, there have been reports of five deaths involving infants 1 to 3 months of age when the product was used for sleep. In most of those incidents, the infants were unrestrained and bedding materials were added to the product.

Consumers are reminded to never use these products for sleep and to never add blankets or other materials to the swing, even after the headrest and the body support insert have been removed. Parents and caregivers should never use any inclined seated products, such as swings, gliders, soothers, and rockers, for infant sleep and should not leave infants in these products unsupervised, unrestrained, or with bedding material due to the risk of suffocation.

Since 2010, approximately 2.1 million swings were sold in the United States, about 99,000 swings were sold in Canada and about 500 swings were sold in Mexico. The recalled Snuga Swing is an infant swing with a front to back and side-to-side motion. The swing has 90 degrees of rotation, two seat back positions and folds up for storage. The Snuga Swing platform has a total of 21 models, which feature the same design with minor differences in fabric colors and toy accessories. The

	their backs for sleep. The best place for an infant to sleep is on a firm, flat surface in a crib, bassinet, or play yard, with nothing but a fitted sheet. Infants who fall		
	asleep in an inclined or upright position should be moved to a safe sleep environment with a firm, flat surface such as a crib, bassinet, or play yard. In 2022, Congress		
	enacted the Safe Sleep for Babies Act, under which inclined sleepers for infants are banned hazardous products.

The Snuga Swings were sold at Amazon, Toys R Us, Walmart/Sams Club, and Target nationwide from October 2010 through January 2024 for about \$160. The swings were distributed by Fisher-Price of East Aurora, New York. The swings are manufactured in China and Mexico.

REMEDING Consumers should immediately remove both the headrest (by cutting the tether) and the body support insert from the seat pad before continuing to use the swing. Fisher-Price will provide a \$25 refund to consumers who remove and destroy the headrest and body support insert. Instructions can be found at www.service.mattel.com.

DESCRIPTION: This recall involves Droyd

multi-purpose helmets for youths. The recalled helmets were sold in sizes medium (M) and large (L). The helmets are black, with black padding, black straps, and a black buckle. "DROYD" is printed on the back of the helmet. Model and serial number are located on the serial number label inside the helmet (e.g. "DHM000001" or "DHL000001").

REMEDY: Consumers should stop using the recalled Droyd helmets immediately and contact Reyhee for a full refund. To receive a refund, consumers must cut the straps off the helmet and submit two photos: one photo of both straps cut off and one photo of the helmet and cut straps inside of a trash can. PRODUCT/FIRM: Gimars Playpens Recalled Due to Entrapment and Suffocation Hazards; Violation of Federal Regulations for Play Yards; Imported by Shenzhen Jingdu Technology and Sold Exclusively on

Amazon.com

DESCRIPTION: This recall involves Gimars Playpens with model numbers GWL-01, GWL-02, GWL-03, GWL-04, GWL-05 and GWL-06. The playpens are labeled with the product name "Gimars Playpen with mat" on a label attached to the top rail. "Gimars" is also printed in white on one side of the top rail. The playpens are dark gray, black and light gray fabric with white mesh sides. The mattress is reversible with printed road and animal designs. The playpens come with a basketball hoop that attaches to the top rail and multicolored balls.

REMEDY: Consumers should immediately stop using and keep children away from the recalled playpens. Consumers should disassemble the playpen and cut the fabric floor, mattress pad and basketball hoop accessory each into two pieces. Then, consumers should upload photos of the cut product using the <u>online submission</u> form or email the photos to <u>Gimars</u>-

Aftersales@outlook.com to obtain a full refund.

PRODUCT/FIRM: NPW Group Recalls Halloween Projector Flashlights Due to Fire and Burn Hazards; Sold Exclusively at Target

DESCRIPTION: This recall involves NPW Halloween Projector Flashlights. The

flashlight is orange with white stripes and a black end piece and measures about six inches long by one inch wide. The product comes with three Halloween themed projector covers, including pumpkin, ghost and skull patterns that fit over the black end piece to change the pattern of the flashlight. The flashlight uses two AA batteries.

REMEDY: Consumers should immediately stop using the recalled flashlights and return them to any Target store for a full refund. Consumers should turn off the product, remove the batteries, mark the product with "recalled" in permanent marker prior to returning the flashlight to Target.
